



Micro Mobility Parking Waiver and Release Form

I _____, hereby request permission to access the designated Micro mobility parking area located in the parking garage for Dominion Towers, accessible by the parking ramp located on Welton Street.

I understand and acknowledge that this storage is specifically used for devices that have been classified as Micro mobility, and is not a public area, but rather, is designated for exclusive use of those individuals, such as myself, who have been specifically authorized to access this area to store Micro mobility devices. No device shall be allowed to be secured to the building, the fence posts, etc. and if it is discovered that this is the case, the lock securing the device to these areas shall be removed and the device shall be left unsecured in this area. I also acknowledge that by signing this Micro Mobility parking Waiver & Release, I have fully read and understand everything identified in this document.

I understand and acknowledge that access to the designated parking area and use of the designated racks is entirely at my own risk and that by signing this waiver, I agree to waive any responsibility or liability on the part of FSP 600 17th Street LLC, its subsidiaries, affiliates, officers, directors, employees, Hines GS Properties, Inc. and Franklin Street Properties LLC and any of its authorized agents, representatives or affiliates, for any bodily injury, death or loss suffered in connection with such use, including any theft of, or damage to, my bicycle or related equipment. Finally, I acknowledge there are spots for approximately twenty-five (25) devices, and I am not guaranteed a spot on any given day, such usage being exclusively on a first come / first served basis. I understand that from time to time, the Landlord may, in its sole discretion, choose to close this area in order to perform maintenance, housekeeping, repairs, staging of equipment or materials for said maintenance or repairs. I also understand the parking garage ramp or garage elevators are to be used upon my arrival and acknowledge the unauthorized use of the service or passenger elevators are not permitted. Further, the Micro mobility parking shall be used only on a short-term basis and shall not be used for an extended period of time. Abuse of this policy will result in the loss of bicycle parking privileges.

Micro Mobility Rules and Regulations

While on Dominion Towers Property employees must store Micro Mobility Devices in the designated area and comply with all Micro Mobility Rules and Regulations:

- Batteries must remain with the Micro mobility device and shall not be permitted to be charged in the building or on site
- Park at your own risk, Dominion towers 600 17th St. is not responsible for items lost, stolen, or damaged.
- Devices left on the property longer than 1 week will be subject to removal and disposal/donation.
- Must lock Micro mobility device to provided racks and stands, and not to any railings guarding building equipment.
- Locks or other items left behind on bike racks will be removed.
